Each rep and individual an American citizen.

Each individual identities, according to blood, racial national or ethnic identity, and place of ancestral origin. Perhaps 30% goes in a category; otherwise, mixed ethnic. Or something. Or whatever one identities with, with sound reasonable basis -- nationality, race, or ethnic group. Each individual may abstain, and participation is both voluntary and a right. Each individual is a Free Person, with rights.

Free Speech – the very Freedom that comes from formulating thoughts, expressing them in print or speech or gesture, that also protects or indicates such right and Freedom of others, is to be protected, by the state (States and Federal Government). Various speech will be this or that; and should protect fundamental rights to reason, standpoint, debate, privacy levels and realization of depth, and appeal to fact, reason, the subjective, and one's own formulation.
